DISCLOSURE TEXT RELATED TO PROCESSING OF PERSONAL DATA

Pursuant to the Personal Data Protection Law ("PDP") No. 6698, your personal data may be processed in accordance with the terms and conditions set forth in the PDP Law by our Company Aladdin Middle East Limited Liability Company - Turkey Ankara Branch ("the Company"), resides in the address of Karum İş Merkezi Iran Caddesi No: 21/394 Kavaklıdere Çankaya/Ankara, as "Data Controller" defined in the PDP Law within the scope described below and within the limits prescribed in the legislation. As the Company, we attach great importance to the security of your personal data. With this awareness, we show maximum sensitivity to the processing and storage of all personal data belonging to all persons associated with the Company in accordance with the PDP law.

1. Collection, Processing and Processing Purposes of Personal Data

Although your personal data may vary depending on the service provided by our Company and the commercial activities of our Company, it may be collected, either automatic or non-automatic methods, by means of our Company units and offices, website and similar means, orally, in writing or in electronic form. Your personal data can be processed and updated as long as you benefit from the products and services offered by our company.

Your collected personal data will be processed within the terms and purposes of the personal data processing described in Articles 4, 5 and 6 of the PDP Law for the purposes of ensuring the legal and commercial security of the persons in business relationship with our company (Administrative operations related to communication carried out by our company, to ensure the physical safety and control of the company's locations, complaint management processes, reputation research processes, event management, legal compliance process, audit, financial affairs and so on), determining and implementing the commercial and business strategies of our company and the executing the human resources policies of our company

2. To Whom and for What Purposes the Processed Personal Data can be Transferred

Your collected personal data may be transferred to the company authorities, shareholders, authorized public institutions and private persons by law, within the terms and aims of the personal data processing described in Articles 8 and 9 of the PDP Law for the purposes of ensuring the legal and commercial security of the persons in business relationship with our Company (Administrative operations related to communication carried out by our company, to ensure the physical safety and control of the company's locations, evaluation processes of business partner / customer / supplier (officials or employees), reputation research processes, legal compliance process, audit, financial affairs and so on), determining and implementing

the commercial and business strategies of our company and the executing of human resources policies of our company.

3. Method and Legal Reason for Collecting Personal Data

Your personal data is collected in all kinds of oral, written or electronic medium for the aims set out above, in order to be able to present the products and services that we offer as Company within the determined legal framework and in order to fulfill the responsibilities of our Company arising from the contract and the law in a complete and accurate manner. Your personal data collected for this purpose may be processed and transferred for the aims specified in the headings 1 and 2 of this text, with the reasons for compliance with the law set forth in Articles 5 and 6 of the PDP Law and the personal data processing requirements.

4. The Rights of the Personal Data Owner Listed in Article 11 of the PDP Law

As personal data owners, if you submit your requests related with your rights to our Company through the methods described in this disclosure text, our Company will finalize the request free of charge within thirty days at the latest, based on the nature of the request. However, if a fee is stipulated by the Personal Data Protection Board, the fee determined will be charged by our Company. In this context, personal data owners have the right to request for followings;

- a. To learn if personal data has been processed,
- **b.** To request personal information if personal data has been processed,
- **c.** To learn the purpose of processing of personal data and if personal data are used appropriate to its purpose,
- **d.** To know the third parties in which personal data is transferred at home or abroad,
- **e.** To request correction of personal data if it is incomplete or incorrect processing and request that the transaction to be notified to third parties in which the personal data was transferred,
- **f.** To request the deletion or demolition of personal data if the reasons for the processing of the data are eliminated, although it has been processed in accordance with the provisions of the PDP Law and provisions other relevant laws, and request that the transaction be notified to the third parties in which the personal data was transferred,
- **g.** To object to drawing a conclusion against the person himself/herself by analyzing the processed data exclusively through automated systems,
- **h.** To demand compensation in case of incurrence of damage due to the illegal processing of personal data.

In accordance with paragraph 1 of Article 13 of the PDP Law, you may submit your request for the exercise of the above-mentioned rights to our company by written or other means determined by the Personal Data Protection Board. In this context, the channels and procedures that you will submit your applications to our Company in writing, within the scope

of Article 11 of the Law on PDP by using the **Application Form** through the link presented are explained below.

In order to use your rights mentioned above, you can send your wet signed and written request involving your explanations about your claim for the rights you want to use among the ones set forth in Article 11 of the PDP Law along with the information that identifies your identity to the address of Karum İş Merkezi Iran Caddesi No:21/394 Kavaklıdere Çankaya/Ankara, by in person or through notary public or by any other means specified in the PDP Law.
